Challenges, and Champions



Early in 2020, there were news reports of a mysterious new virus emerging across the globe. As winter was turning to spring in the Northern Hemisphere, the virus arrived on our doorstep. Across the world, and here

at home, we experienced an array of new concerns and fears. How can I keep my family safe? How will I earn a living? Will the sick be able to access hospital care? Will there be food and essentials on the store shelves?

These frightening realities, seemingly new to us, gave us a deeper understanding of, and appreciation for, the hardships that families in rural India face every day when living in poverty. Tragically, it seems that when disaster strikes, usually the poorest of the poor are hit the hardest. In this newsletter, we'd like to share with you the good news of how our collective efforts have responded to extraordinary challenges.

Extraordinary Generosity

In India, an estimated 43-million people have been infected and more than half a million have died. The actual numbers may be much higher. In response to urgent humanitarian need, Save A Family Plan launched a special Covid-19 assistance fund. The generosity from our supporters was nothing short of incredible. Through your outpouring of care and kindness, we were able to meet and surpass our target of \$75,000. THANK YOU! Those funds continue to help people as India and the world recover from the global pandemic.

Thanks to your generosity, SAFP partner families have

received urgent assistance to help meet their immediate needs such as food, water, medicine, masks, and hand sanitizer. As part of the Covid-19 Fund, families in the Family Development Program were also eligible for

financial support to help them re-establish small business initiatives that foundered during the pandemic, or in starting new ones. The work is underway, and continues still. All of these emergency initiatives are in addition to the work already being done with our partner families and communities in India.

Extraordinary Efforts

With challenges heaped upon challenges, life became even more difficult in India. Restrictions, lockdowns, and infrastructure closures brought all manner of challenges for our SAFP India team. Focused as always on the people we serve, the SAFP India team rose to the occasion. They found creative and meaningful ways to continue to support all of our partner families and communities. More on that in a moment.

At the same time as the pandemic raged, the Indian government implemented new regulations concerning the receipt of foreign funds. The Foreign Contributions Regulations Act (FCRA) meant having to cut the number of staff who could be employed in order to implement our vital programs, just when we needed staff more than ever. The result was a combination of partner families in dire need and much more responsibility shared among many fewer workers.

With heavy hearts, Save A Family Plan had to say goodbye to our beloved Animators, who [continued...]



for years, had provided direct personal support to our partner families. This resulted in a modified and increased workload for our Coordinators, who worked tirelessly to ensure that the care provided to our partner families continued without interruption.

In the Save A Family Plan India office, Mary and Sibi are the Accounting Coordinators. As a result of FCRA, they were tasked with helping nearly 8,000 families to close existing bank accounts and open brand new onesright in the thick of a pandemic, when it was difficult or impossible to physically enter a bank. supports, this vast and time-consuming process meant working late into the evenings, and often six days per week.

The Community Development Program continues to be managed with incredible competence and care by Shibin, the Program Manager, under the direction and support of Fr. Marshel. Changes to the Community Development Program are underway and will help to ensure that SAFP is compliant with the new FCRA regulations mentioned earlier. This, unfortunately, meant losing some longstanding NGO partnerships that helped us do so much good within communities in need.

Likewise, Beena, Manu, and Alto, our Family Development Program team, showed true grace under pressure. As a consequence of the changes, responsibility for all program implementation now rests on just these three individuals. Many tasks, existing and new, had to be done remotely or socially distanced. Each FDP staff visits the NGOs to monitor the programs and verifies applications and reports of nearly 2500 partner families!
