

#### Some Common Myths about Wills

Myth: "Wills are for the wealthy." Wills deal with more than money or property. A Will can protect your children or grandchildren, name caretakers for pets, leave instructions for digital assets, outline your funeral wishes, and more.

Myth: "My family already knows my wishes." It is never safe to assume that everyone understands and remembers your wishes, and agrees what those actually are. Wishes only become plans when they are written down. Without a plan spelled out in your Will, the courts may have to decide on your behalf, taking time and money away from your family during an already difficult time.

Myth: "Wills are for the elderly." Everyone should be prepared, whether they are 18 or 118. Every adult should have a Will and keep it up to date (usually every 5 years or after a significant change such as the birth of a new grandchild).

You should obtain independent, professional advice when preparing your Will and considering your financial assets, tax advantages, and other details.
